MINUTES OF THE MEETING HELD ON 6TH MARCH, 2014 IN THE CHIEF MINISTER'S SECRETARIAT.

A meeting alongwith presentation was held under the chairmanship of Hon'able Chief Minister, at the Conference room of Chief Minister's Secretariat, on 6th March 2014 at 12pm which was attended by Minster Elementary and Secondary Education, Principal Secretary to HCM, Secretary Elementary and Secondary Education Department, Special Secretary to HCM, Chairman and Secretaries of all BISEs.

Chairman BISE Peshawar gave a detailed presentation to the chair about the reforms being taken in the examination structure of the boards. He briefed the chair and participants about the strategy being chalked out for conducting transparent upcoming matric exams which included voluntarily installation of cameras in examination halls of some private schools, increase in fee of checkers, enhanced TA/DA of staff, decrease in quantity of paper checking per day to ensure quality etc

Following decisions were taken:-

- 1. During examination, the halls having CCTV cameras, recording of hall activities will be made and kept on record for future reference in case of any complaint.
- 2. The banners regarding cheating in examination should also inscribe the slogans for parents to discourage and warn their children regarding use of unfair means in the examinations.
- 3. The Elementary & Secondary Education Department will reflect and allocate budget for installation of cameras in the examination halls of Govt: Schools in the budget of next financial year 2014-15.
- 4. Report on 5th & 8th classes examination will be completed & compiled by Elementary & Secondary Education Department in the next two weeks.
- 5. Electronic & print media person will be invited and briefed about the ongoing changes/amendments for the transparent conduct of examinations.
- 6. DCs/DPOs of each district will be asked by the High ups to assist & cooperate with BISEs authorities in the examinations.

- 7. Elementary & Secondary Education Department world suggest measures how to get rid of the current rote system to replace the present education system.
- 8. In case of any complaint regarding selling of examination centre or cheating in examination, the Chairman of concerned Board will be personally held responsible.
- 9. Chairmen of all BISEs will check the marked papers randomly to maintain transparency and quality marking by the checkers.
- 10. Strict disciplinary action will be taken against the supervisory staff in case of their involvement in cheating or using any unfair means.
- 11. Each BISE in Khyber Pakhtunkhwa will advertise and publish contact numbers of Complaint Cell in the press. Separate Complaint Cell equipped with all facilities will be functional in all BISEs during examination.
- 12. Supervisory Staff involved in unfair means during examination will be punished by a committee to be constituted by Chairman. Suggestions in this regard will be put up to the Chief Minister Khyber Pakhtunkhwa through Secretary and Minister Elementary & Secondary Education Department.
- 13. Names of the schools/institutions wherein CCTV cameras are installed will be advertised in the press to encourage other educational institutions in this regard.
- 14. Chief Minister/ Minister (E&SE) will visit BISE Peshawar to encourage the institutions to instal cameras and highlight the act.

At the end, the Hon'able Chief Minister again stressed for conducting of cheating free, transparent and merit based marking exams.

Meeting ended with a note of thanks to and from the chair.
